This year we are particularly honoured to have **Hans-Joerg Rudloff, Chairman, Barclays Capital**, as our guest speaker. Hans-Joerg Rudloff joined Barclays Capital in 1998, where he presently serves as the Chairman of the Executive Committee and as the Chairman of the Barclays Private Equity.

Mr. Rudloff started his professional career in 1965, when, after completing studies in economics at the University of Bern, he joined Credit Suisse in Geneva. He moved to the US-based investment banking firm of Kidder Peabody Inc. in 1968, where he later headed Swiss operations and was elected Chairman of Kidder Peabody International. He became a member of the Board of Directors of Kidder Peabody Inc., United States, in 1978. Two years later he joined Credit Suisse First Boston, Switzerland, where he was elected Vice Chairman in 1983, and was appointed Chairman and Chief Executive Officer from 1989 to 1994. Following this, Mr. Rudloff became the Vice Chairman of Novartis AG in 1996 and served as its Independent Non-Executive Director until recently.

Hans-Joerg Rudloff became Chairman of the International Capital Markets Association (ICMA), Switzerland in 2005, and in 2006, he joined the Board of Directors of Rosneft, a Russian state-controlled oil company, where he was appointed Chairman of the audit committee. He has been Vice-Chairman of Rosneft Oil Company since June 10, 2011. Additionally, he serves as a Director of the TBG Group (Thyssen-Bornemisza Group), OAO RBC Information Systems, Marcuard S.A., RBC, OAO Rosneft, and Rosneft OJSC and is a Member of the Advisory Board at Landeskreditbank.
